

# Your CAHF PAC and PAF Contributions At Work

- Successfully defeated legislation that would have significantly harmed nursing providers, including mandated wage increases without reimbursement, and prohibitions on SNF operations during declared emergencies
- Secured critical amendments to protect the industry from costly penalties, licensing delays, and stringent reporting
- Activated more than 8,000 members to help obtain more ICF funding and hold hostile bills
- Worked with a coalition to remove a ballot initiative that would have allowed limitless liability damages against health providers
- Helped qualify a ballot initiative that would stop frivolous lawsuits against SNFs
- Contributed to 82 candidates, helping them secure election to office
